















Textile & Leather Products Recall Notifications-2022 report 01

EU, USA, Canada and Australia have established rapid alert systems to facilitate the rapid exchange of infor mation and measures taken to prevent or restrict the marketing or use of products posing a serious risk to the health and safety of consumers. CTT Textile and Leather Recall Notification Alert No. 1 of 2022 summarizes th e first quarter notification information related to textile and leather products. The USA, EU and Australia rep orted a total of 52 cases during the period and no recall cases in Canada.






Textile & Leather Products Recall Notifications-2022 report 01





Among the recall cases in this quarter, the proportion of recalls caused by choking hazard was as high as 41%, strangulations risk accounted for 19%, flammability accounted for 19%, and chemical hazards accounted for 17%. The chemical hazards mainly come from the excessive content of lead, azo, phthalates, SCCPs and the excessive release of nickel. Among the countries of origin of all recalled products, there were 22 products from China, accounting for 41% of the tot al number of recalls, ranking first.

Product: Children's Nightgowns

Country of origin: China Alert submitted by: USA

The children's nightgowns fail to meet federal flammability stand-Risk type: ards for children's sleepwear, posing a risk of burn injuries to chil-

dren.

Consumers should immediately take the recalled nightgowns away from children and stop using them. Consumers who purchased the

garments from Amazon.com will be contacted through Amazon's messaging platform and provided prepaid mailers to return the

products for a full refund.

Product: Sweater

Country of origin: China

Product : Beach sandals

Risk type:

The product contains an excessive amount of bis(2-ethylhexyl)

phthalate (DEHP) (measured value up to 1.6% by weight). This phthalate may harm the health of children, causing possible

damage to their reproductive system.

Measures ordered: Import rejected at border (By: importer).

Different markets have different requirements for textiles and leather footwear products. Therefore, it is particularly important to understand the requirements of export markets for products, especially for children's products, and to design and produce in strict accordance with relevant regulations and standards. Avoid the risk of recalls or claims due to product quality issues.






本季度召回案例中,窒息危害产生的召回比例高达41%;绞勒风险占19%;燃烧风险占19%;化学危害 占17%,主要包括铅、偶氮、邻苯二甲酸盐、短链氯化石蜡含量超标,镍释放超标等。所有被召回产品的原产 国中,来自中国的产品共22例,占召回总数的41%,位列第一。

原产国: 中国

通告国: 意大利

风险描述: 该产品含有过量的邻苯二甲酸酯(DEHP)。这种邻苯二甲酸盐可能会损害

儿童的健康,可能会对他们的生殖系统造成损害。

· | 采取措施: 由分销商从市场将产品上撤回。

各个市场对于纺织品及皮革鞋类产品的要求不尽相同,因此,了解出口市场对产品的要求,尤其是儿童产品的要求,并严格按照相关法规和标准进行设计和生产则显得尤为重要,避免因产品质量问题而导致召回或产生索赔的风险。
