



Textile & Leather & Shoes & Bag Products Recall Notifications - 2024 report 3

In order to protect the legitimate rights and interests of consumers, countries such as the European Union, the United States, Canada and Australia have established special early warning and notification mechanisms to notify substandard products. CTT summarizes the notification information related to textile & leather & shoes & bag products in the third quarter of 2024. During this period, the European Union announced 44 notified cases, the United States announced 6 notified cases, Canada announced 5 notified cases, and Australia announced 10 notified cases, for a total of 65 cases. Among the countries of origin involved, including China, Turkey, India, Bangladesh, Austria, Portugal and so on, among which 43 cases were related to China, accounting for 66.2%; The types of risks involved in the recalled products include: rope straps cause injury & strangulation hazard, burn hazard, chemical hazard, small parts choking hazard, etc. More details are as follows:

Some typical cases are as follows:



Product:	Children's two-piece pajama sets
Country of origin:	China
Alert submitted by:	United States、Canada
Risk description:	The children's pajama sets violate the federal flammability standards for children's sleepwear, posing a burn hazard to children. The recalled two-piece pajama sets do not meet the flammability requirements for children's sleepwear, posing a risk of burn injuries to children.
Measures ordered:	Consumers should immediately stop using the recalled Two-Piece Pajamas and contact the company to receive a refund.



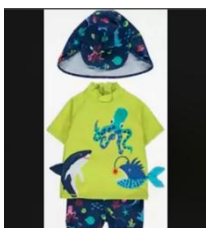
Product:	Slippers
Country of origin:	China
Alert submitted by:	Sweden
Risk description:	The plastic material of the shoes contains excessive concentrations of bis(2-ethylhexyl) phthalate (DEHP) and dibutyl phthalate (DBP) (measured values up to 1.2% and 20% by weight, respectively). These phthalates may harm the health of children by causing possible damage to their reproductive system. Moreover, it contains cadmium and lead (measured values up to 0.026% and 0.084% by weight, respectively). Lead is harmful to human health, accumulates in the body, can cause developmental neurotoxicity and may also affect breast-fed or unborn children. Cadmium is harmful to human health because it accumulates in the body, can damage the kidneys and bones, and it may cause cancer.
Measures ordered:	Removal of this product listing by the online marketplace.



Product:	Children's jumpsuit
Country of origin:	Democratic People's Republic of Korea
Alert submitted by:	Cyprus
Risk description:	The product has long functional cords with free ends in the shoulder area which can become trapped during various activities of a child, leading to injuries.
Measures ordered:	Withdrawal of the product from the market.



Product:	Children's dress
Country of origin:	Turkey
Alert submitted by:	Hungary
Risk description:	The small decorative elements (rhinestones and half beads) can easily be detached from the dress. A small child may put the small parts in the mouth and choke and the safety pin can cause eye or skin injuries.
Measures ordered:	Recall of the product from end users. Withdrawal of the product from the market.



Product:	Children's clothing set (UV protection)
Country of origin:	China
Alert submitted by:	Ireland
Risk description:	The product presents a risk of burns. Without additional sun protection, children may be at risk of burns on exposed areas of their arms and legs.
Measures ordered:	Recall of the product from end users.

Product:	Baby lightweight quilt
Country of origin:	Turkey
Alert submitted by:	Bulgaria
Risk description:	Due to the weakness of the seams, the filling in the product is easily accessible. A child may put it in the mouth and choke. Moreover, the product has threads that can easily detach. These can become wrapped around the children's body or limbs or can wrap around the child's neck, leading to strangulation.
Measures ordered:	Import rejected at border.



Product:	Baby girl infant sleepers
Country of origin:	Bangladesh
Alert submitted by:	Canada
Risk description:	The snap-on from the garment may detach, posing a choking hazard to young children.
Measures ordered:	Consumers should immediately stop using the recalled product and return it to the company for refund.



Product:	Bag
Country of origin:	China
Alert submitted by:	Sweden
Risk description:	The plastic material of the bag has an excessive amount of di-2-ethylhexyl phthalate (DEHP) (measured value: 13% by weight). This phthalate may harm the health by causing possible damage to the reproductive system.
Measures ordered:	Removal of this product listing by the online marketplace.



Product:	Children's jersey sleep bags
Country of origin:	China
Alert submitted by:	Australia
Risk description:	The products do not have the required fire hazard labelling. There is a risk of serious burn injuries if exposed to a heat or flame source. Consumers may not be aware of this hazard.
Measures ordered:	Consumers should stop using these products immediately. Consumers should return the product to their place of purchase to have the required warning label attached.



Product:	Headlights for crocs shoes
Country of origin:	China
Alert submitted by:	Australia
Risk description:	The button/coin batteries are not adequately secured and are accessible to young children. The product does not include the required warning information. There is a risk of choking, severe internal burn injuries or death to young children if they gain access to the button/coin batteries and swallow them or place them inside their body.
Measures ordered:	Consumers should stop using the products immediately and place out of reach of children. Consumers should dispose of the product, take a photograph and send the photo to the seller for a full refund.

Different markets have different requirements for textiles & leather & shoes & bag products. Therefore, it is particularly important to understand the requirements of export markets for products, especially for children's products, and to design and produce in strict accordance with relevant regulations and standards. Avoid the risk of recalls or claims due to product quality issues.

纺织和皮革鞋包类产品召回通报预警-2024年第3期

为了保障消费者的合法权益，欧盟、美国、加拿大和澳大利亚等国家建立了专门的预警通报机制，对不合格产品进行通报。CTT汇总了2024年第三季度纺织和皮革鞋包类产品的通报信息。在该期间，欧盟公布通报案例44例，美国公布通报案例6例，加拿大公布通报案例5例，澳大利亚公布通报案例10例，共65例。所涉及的原产国，包括中国、土耳其、印度、孟加拉、奥地利和葡萄牙等，其中与中国相关的有43例，占66.2%；所涉及的召回产品风险类型包括：绳带引起受伤&绞勒危害、烧伤危害、有害化学物质超标危害、小部件窒息危害等。更多详情如下：

采取措施:	消费者应立即停止使用召回的两件套睡衣，并联系商家要求退款。



产品:	拖鞋
原产国:	中国
通告国:	瑞典
风险描述:	鞋子的塑料材料含有过量浓度的DEHP和DBP（测量值分别高达1.2%和20%（按重量计））。这些邻苯二甲酸盐可能会对儿童的生殖系统造成损害。此外，它还含有镉和铅（测量值分别高达0.026%和0.084%（按重量计））。铅在人体内积聚，可引起发育神经毒性，还可能影响母乳喂养或未出生的儿童。镉在人体内积聚，会损害肾脏和骨骼，并可能导致癌症。
采取措施:	从在线市场上移除此产品信息。

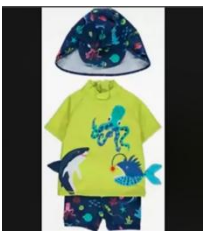

产品:	儿童连衣裤
原产国:	朝鲜
通告国:	塞浦路斯
风险描述:	该产品在肩膀区域有很长的带有自由末端的功能绳, 在儿童的各种活动中可能会被绊住、困住, 导致受伤。
采取措施:	产品从市场上撤回。



产品:	儿童连衣裙
原产国:	土耳其
通告国:	匈牙利
风险描述:	小装饰元素(水钻和半珠)可以很容易地从裙子上分离出来, 小孩子可能会把它放进嘴里吞咽并导致窒息。蝴蝶结别针可能会刺伤眼睛或皮肤。
采取措施:	从最终用户手中召回产品; 产品从市场上撤回。



产品:	儿童套装(防紫外线)
原产国:	中国
通告国:	爱尔兰
风险描述:	该产品有被灼伤的风险。如果没有额外的防晒措施, 儿童的胳膊和腿的暴露区域可能会有被晒伤灼伤的风险。
采取措施:	从最终用户手中召回产品。



产品:	婴儿轻质被子
原产国:	土耳其
通告国:	保加利亚
风险描述:	由于接缝缝线薄弱, 产品中的填充物很容易获得。小孩子可能会把填充物放进嘴里吞咽并导致窒息。此外, 该产品的缝线很容易脱落, 这些缝线可能会缠绕在孩子的身体或四肢上, 也可能缠绕在孩子的脖子上, 导致受伤或窒息。
采取措施:	边境拒绝进口



产品:	女婴连体睡衣
原产国:	孟加拉
通告国:	加拿大
风险描述:	衣服上的卡扣可能会脱落, 对幼儿造成窒息危险。
采取措施:	消费者应立即停止使用召回的产品, 并将其退回给商家进行退款。

原产国:	中国
通告国:	瑞典
风险描述:	布袋的塑料材料含有过量的DEHP（测量值：13%（按重量计））。这种邻苯二甲酸盐可能会对生殖系统造成损害，从而损害健康。
采取措施:	从在线市场上移除此产品信息。



产品:	儿童睡袋
原产国:	中国
通告国:	澳大利亚
风险描述:	产品没有所需的防火标签。如果暴露在热源或火源中，则有严重烧伤的风险。
采取措施:	消费者应立即停止使用这些产品，将产品退回购买地，以贴上所需的警告标签。



产品:	洞洞鞋鞋头灯
原产国:	中国
通告国:	澳大利亚
风险描述:	纽扣/硬币电池没有充分固定，幼儿容易接触到。该产品不包含必要的警告信息。如果幼儿接触到纽扣/硬币电池并将其吞下或放入体内，则有窒息、严重内灼伤或死亡的风险。
采取措施:	消费者应立即停止使用有关产品，并应放在儿童接触不到的地方。消费者应丢弃商品，拍照并将照片发送给卖家以获得全额退款。

各个市场对于纺织品及皮革鞋包类产品的要求不尽相同，因此，了解出口市场对产品的要求，尤其是儿童产品的要求，并严格按照相关法规和标准进行设计和生产则显得尤为重要，避免因产品质量问题而导致召回或产生索赔的风险。
