




Toy Products Recall Notifications-2026 report 01

In order to protect consumer legitimate rights, the European Union, UK, USA, Canada, Australia together with other countries in the world has established special notification systems to provide information of products which may cause risk to people health and safety.

A total of 45 notifications of children's toys were declared in EU RAPEX are from United Kingdom in respect of Northern Ireland, Poland, Germany, Spain, Austria, Lithuania, France, Slovenia, Sweden, Slovakia; 2 notifications in UK official for product safety and Standards website; 0 notifications in Healthy Canadians official website; 7 notifications in Australian product safety recalls official website; 6 notifications in CPSC official website from 1 to 4 week of 2025. **Up to 59 notifications of children's toys are from China among all those notifications.** Toys were notified because : Contain or release small parts, High Phthalates, Product posing fire risk etc. Some toys are subject to notifications for more than one reason.



A child may put them in the mouth, which could cause them to choke or they can be swallowed, which could cause damage to the child's gastrointestinal tract. The battery compartment could create a short circuit, causing the toy to heat up leading to a risk of burns. Moreover, the product emits overly bright light. 


2026年第1-4周，欧盟RAPEX通报公布的玩具通报案例共45例，来自北爱尔兰、波兰、德国、西班牙、奥地利、立陶宛、法国、斯洛文尼亚、瑞典、斯洛伐克；英国产品安全与标准部门官网2例，加拿大卫生部官网0例，澳大利亚产品安全召回官网7例，美国CPSC官网6例。**所有的通报案例当中原产国是中国的案例高达59例**，涉及的通报原因包括含有或易产生小部件，邻苯二甲酸酯超标，起火风险等，部分玩具涉及的通报原因不止一项。
