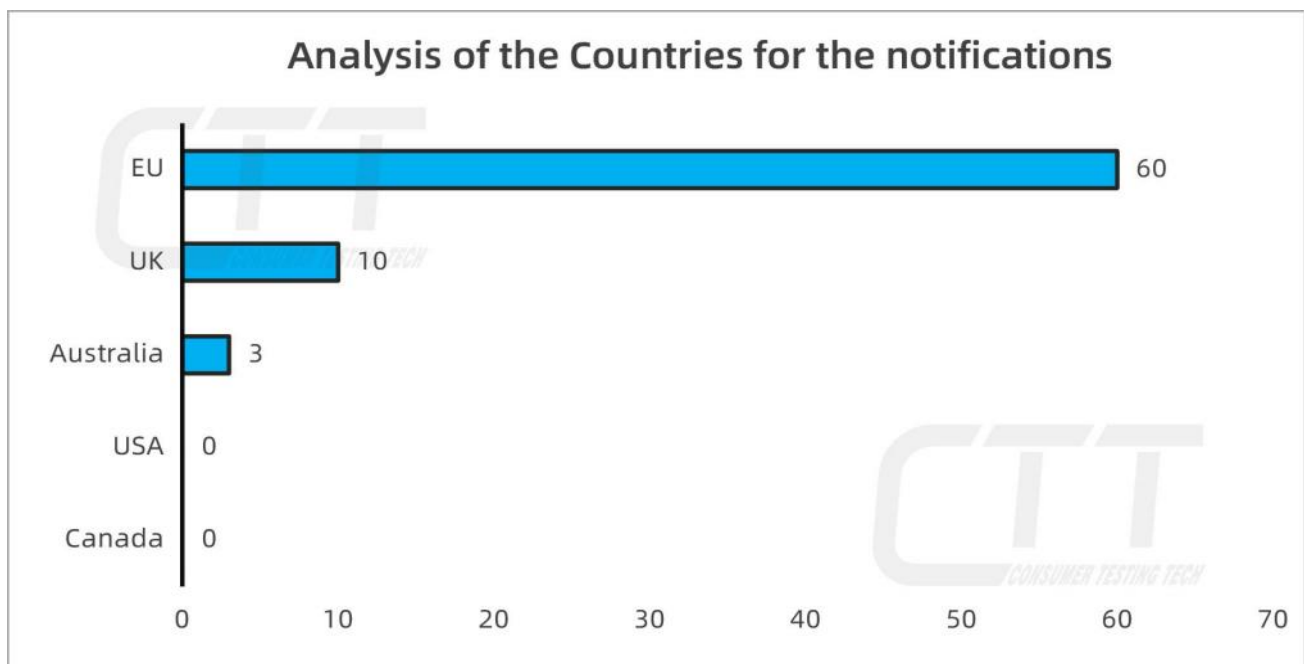




Toy Products Recall Notifications-2024 report 10

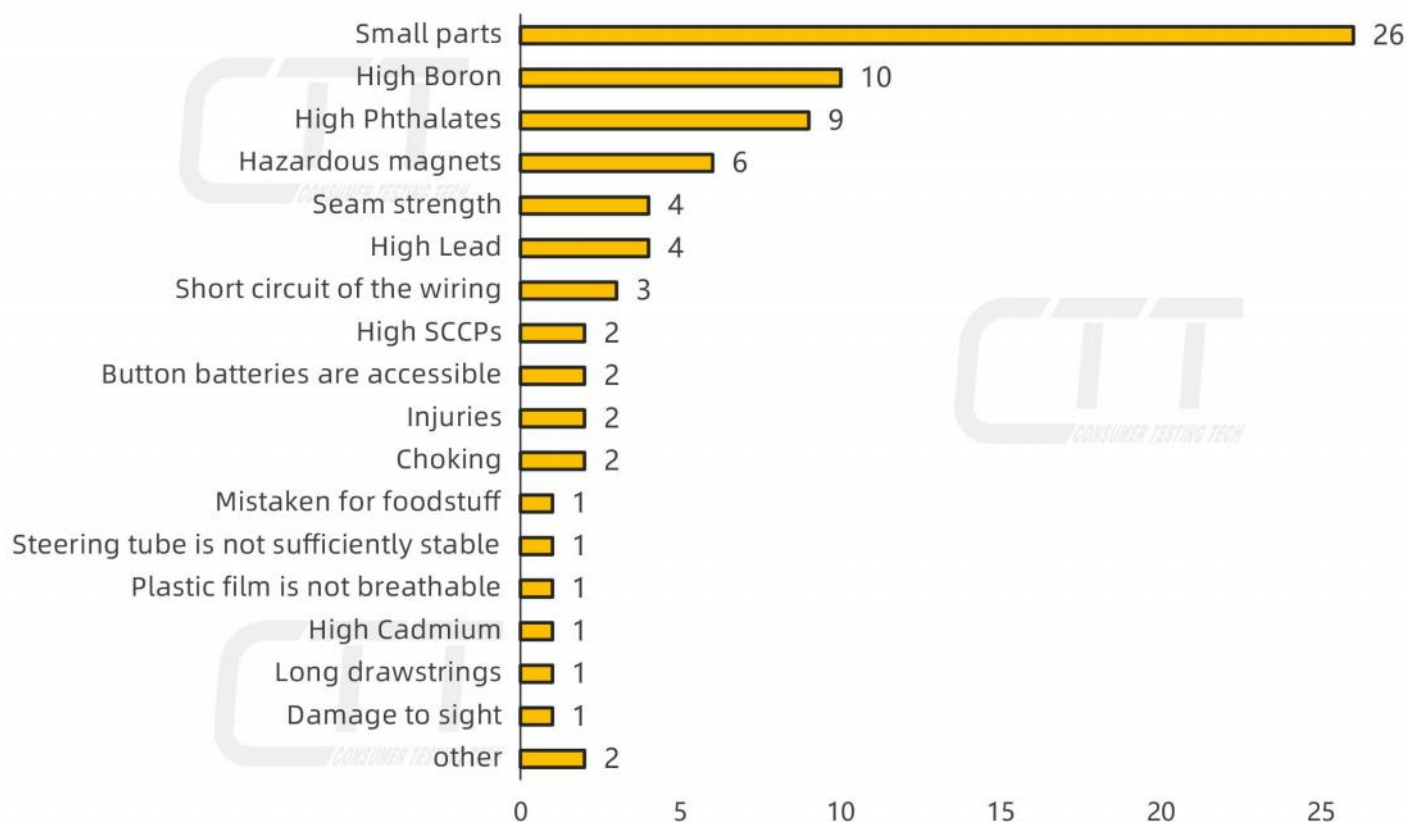
In order to protect consumer legitimate rights, the European Union, UK, USA, Canada, Australia together with other countries in the world has established special notification systems to provide information of products which may cause risk to people health and safety.

A total of 60 notifications of children's toys were declared in EU RAPEX are from **Cyprus, Spain, Germany, France, Poland, Czechia, Lithuania, Malta, Croatia, Hungary, Sweden**; 10 notifications in UK official for product safety and Standards website; 0 notification in Healthy Canadians official website; 3 notifications in Australian product safety recalls official website; 0 notification in CPSC official website from 40 to 43 week of 2024. **Up to 67 notifications of children's toys are from China among all those notifications.** Toys were notified because : Contain or release small parts, The migration of boron from the product is too high, Phthalates content exceeds the limit level, etc.






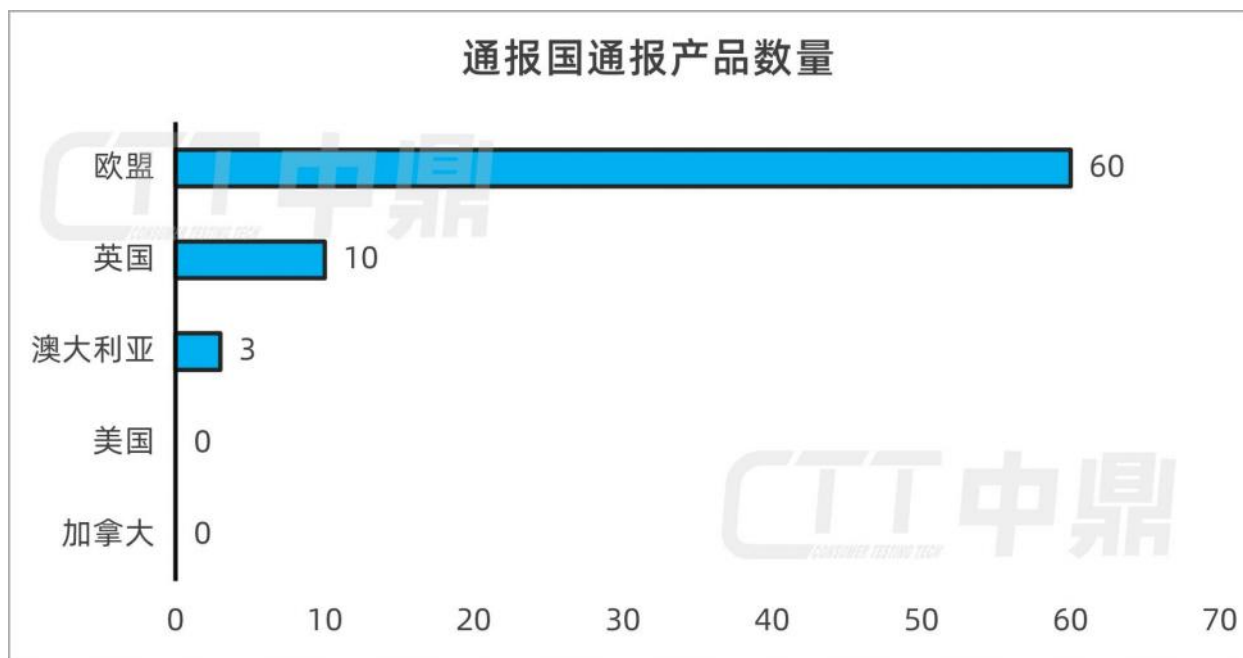

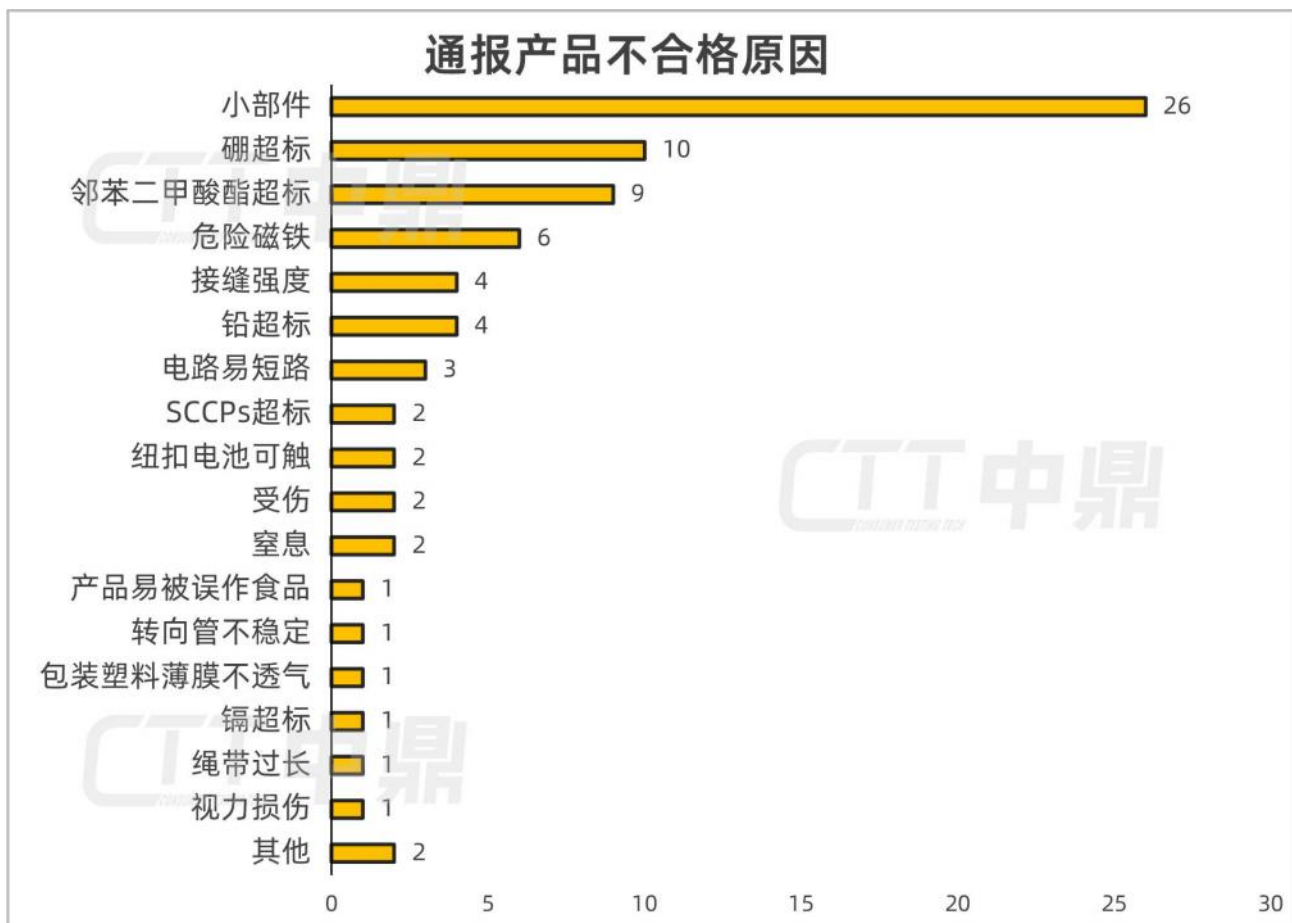
为了保障消费者的合法权益，欧盟、英国、美国、加拿大、澳大利亚等国均建立了专门的预警通报机制，对不合格的玩具产品进行通报。

2024年第40-43周，欧盟RAPEX通报公布的玩具通报案例共60例，来自奥地利、塞浦路斯、爱沙尼亚、芬兰、法国、德国、立陶宛、波兰、罗马尼亚、斯洛文尼亚、瑞典；英国产品安全与标准部门官网10例，加拿大卫生部官网0例，澳大利亚产品安全召回官网3例，美国CPSC官网0例。**所有的通报案例当中原产国是中国的案例高达67例**，涉及的通报原因包括含有或易产生小部件，产品的硼迁移量过高，邻苯二甲酸酯含量超标等。
